- 1. 2010 Audit Status Mr. Vasey reported he is awaiting auditor's reply to request for status.
- 2. 2011 (Writing) Essay Contest Results Three essays were received for entry into the contest. Unfortunately, none of the essays satisfied the requirements set forth in the contest rules. All entrants will, however, receive a certificate of participation.

VIII. New Business

- 1. AFCD Area IV Resolution Mr. Vasey drafted a response to the AFCD resolution banning point source pollution. As agreed by the Board, Ms. Bucceri will prepare and distribute the response resolution. Mr. Lang described the benefits of ASR wells (700'-800' deep) as they are being used on Marco Island to store rain/storm water, overflow from the rainy season, etc. to help prevent flooding and to store water for drought/dry season use. Mr. Lang will forward a web address for a site he feels explains in better detail the ASR well process. Mr. Lang and Mr. Ramsey discussed the differences between ASR wells and deep injection wells (3,500'-5,000' deep). Injection wells receive treated sewage water/waste water. This process is permanent. Injected water is lost to the ecosystem forever.
- 2. Vehicle Expense Card from NRCS Ms. Bucceri reviewed with the Board a message stating Deborah Lee, NRCS vehicle custodian, among other things, has ordered a new gas credit card for CSWCD, to be used with the 2008 Ford pickup currently belonging to the NRCS being used by the Collier Urban MIL to perform irrigation evaluations. This relieves the District of paying for gas and maintenance for the government's vehicle. Ms. Bucceri will notify the Board when the new card is received.
