## VI. Reports

- 1. District Conservationist's Report Mr. Bob Beck, District Conservationist Mr. Beck reviewed his monthly report. Supervisor Weiner has applied and been accepted as an NRCS volunteer and will begin training soon.
- 2. District Consultant's Report Mr. Michael Ramsey Mr. Ramsey has been working at Benfield Road area and also in Everglades City, replacing some of the trees that did not survive original installation.
- 3. Lower West Coast/Big Cypress Basin MIL Mr. "Nik" Nikolich of the BCB Urban Lab described recent activities and reviewed the billing process through Big Cypress Basin. Mr. Mark Siverling of the LWC Ag Lab explained that the contract renewal with FDACS is calling for performance of more duties without benefit of a budgetary increase. In addition, SFWMD has asked that MIL do pump calibrations. Mr. Siverling had suggested using the new flow meter as a source of extra income. He will gather information on education in the use of the flow meter. Mr. Vasey suggested going through FDACS and SFWMD and asking if either agency would agree on the type and extent of this work and if they would be willing to increase payments for it. Mr. Ramsey is interested in helping to set this up as a business for the District. Mr. Siverling had also requested approval of a \$1,000.00 expense for classes and for renewing membership in the Irrigation Association. Mr. Weiner motioned for approval, Mr. Lang 2<sup>nd</sup>, all ayes, budget request approved.

- Discussion Performance Review Budgeting Ms. Bucceri presented the budget to include a 2.5% cost of living increase for District employees.
